4.1. Description of first aid measures

During the risk assessment process, it is essential to take into consideration the ACGIH occupational exposure levels for particulate not otherwise classified (PNOC respirable fraction: 3 mg/m3; PNOC inhalable fraction: 10 mg/m3). 8.2. Exposure controls

Silicates react with powerful oxidants such as fluorine, boron trifluoride, chlorine trifluoride, manganese trifluoride and oxygen bifluoride.
